Subject:- Submission of monthly Madwar copy pertaining to Major Heads :
0040- Sales Tax, 0042 - Passenger Tax and 0030 - Stamps &
Registration.

C I R C U L A R

The matter regarding submission of monthly Madwar copy pertaining to Major Heads : 0040- Sales Tax, 0042 - Passenger Tax and 0030- Stamps & Registration was discussed threadbare in the review meeting of Treasury Officers of Kashmir Division, held under the chairmanship of Hon'ble Minister for Finance & Ladakh Affairs on 06.02.2013. It was desired that even the treasuries not dealing with the stamps, are also required to submit, on the prescribed format, the copy of Madwar pertaining to MH : 0030- Stamps & Registration to the Deputy Commissioner Stamps, Srinagar/ Jammu, as the case be. It was also clarified that even when there be no transaction in respect of MH : 0030 during a particular month, still a 'Nil' copy of Madwar is required to be submitted by the Treasuries.

2. Further , it also needs to be emphasised that the State of Jammu & Kashmir is receiving major chunk of revenue from works contracts. 100% tax on contracts is deducted at source and deposited in the treasuries. The conduct of executing agencies in this behalf and position of revenues, as such, cannot be effectively monitored unless the Madwars from the treasuries, on the prescribed formats, are not received by the Addl. Commissioner, Commercial Taxes (Adm.), Srinagar / Jammu and that, too, on regular basis.

3. All the Treasury Officers are , therefore , enjoined to furnish henceforth invariably a copy of monthly Madwar pertaining to Major Heads: 0040- Sales Tax and 0042 - Passenger Tax to the Addl. Commissioner , Commercial Taxes (Adm.) Srinagar / Jammu and to MH : 0030- Stamps & Registration, to the Deputy Commissioner Stamps , Srinagar / Jammu on the prescribed format. The instructions, so issued , are required to be adhered to by the Treasury Officers in letter and spirit and any deviation from the instructions shall render the concerned Treasury Officer(s). liable for disciplinary action under rules.
