## CIRCULAR

Public Works Department has launched a web portal JKPWD-Online Management, Monitoring & Accounting System (JKPWDOMS) in Public Works Department vide Government Order No. 247-PW (R&B) of 2020 dated 31.08.2020 followed by Government Order No. 186-PW (R&B) of 2023 dated 08.05.2023. The portal has features of online generation and submission of works bills (Revenue / Capital Expenditure/ Budget including works of other departments executed on deposit contribution basis) by the Executive Engineer of PWD (R&B) Department through Online Management, Monitoring and Accounting System only, from preparation of measurement book and submission of bills forthwith. As per the Government Order bills on JK Paysys application shall have the following details without exceptions:-

- a. Copy of Administrative Approval and Technical Sanction.
- b. Tender document / NIT.
- c. Allotment Order / Contract Agreement.
- d. Online M. Book.
- e. Geo-tagged photographs of the works at various stages.

Consequent upon implementation of JKPWDOMS, Treasury Officers are directed to entertain only those Works bills of PWD Department (both civil and mechanical debit able to CAPEX and Revenue Budget) including the works of other departments executed by the PWD on Deposit contribution basis which have been initiated and processed through JKPWDOMS Application and routed through JKPaySys. The Executive Engineer of the concerned Division shall also upload certificate with the payments claim presented to Treasury in online mode that bill presented for payment has been initiated / generated through JKPWD OMS Application. Any work bill that has not been generated / submitted to Treasury through JKPWDOMS shall be out rightly rejected and matter be brought to the notice of Finance Department / Public Works Department for appropriate action against the erring DDO.

 $\sim$  Any claim which has not been generated on JKPWDOMS and preferred by the

DDO and cleared by the Treasury, both DDO & Treasury Officer concerned shall be held personally responsible.
