Subject: Phishing email to mislead the DDOs and employees by unknown senders.

1. The NIC has brought to the notice of this Directorate that a phishing e-mail to mislead the DDOs & employees has been sent to some of the DDOs/employees by an unknown sender seeking certain information from them by using google form.
2. The sender has created a fake email id jkpaysys.gov.jk@gmail.com which is a type of phishing fraud.
3. Phishing mail circulated in social media is reported to have been sent to some of the e-mail addresses viz –

  - ii) ARSHIDTHOKERAP@gmail.com

  - iv) ASRARPANZGAMI@gmail.com

4. This is for information of all the DDOs and Treasury Officers that –
  - a) JKPAYSYS operates through its own govt. mail address as mentioned in the site and there is no alternate e-mail for this on any commercial server such as gmail, yahoo etc.
  - b) Such a phishing e-mail might be the mischievous attempt to hamper the site's performance. Responding such unauthentic e-mail, might lead to compromise with the security of data.
  - c) There is an existing help desk of NIC.
  - d) Support team of NIC is available only to provide the technical support to Drawing and Disbursing Officers/Treasury Officers and never seeks any information from anyone at its own. The e-mail sent by the support team is just a solution to the issues/queries raised by the individuals.
