CIRCULAR

- a) The JKPaySys shall remain operational on 31st March 2023 from 9:00 A.M to 11:00 A.M for generation/submission of bills to treasuries.
- b) The DDO's shall generate/submit bills after observing all prescribed codal formalities and any lapse on part of rejection made at treasuries for want of codal formalities/miscalculation will be sole responsibility of DDO concerned.
- c) The DDO's shall submit the hard copies of the bills to concerned treasuries by or before 12:00 O'clock.
- d) The Bills / Claims so presented are liable to special audit wherever required.
- e) Treasury Officers shall entertain the claims from DDO's duly complete in all respect upto prescribed timings and subsequently submit the liability by or before 1:00 P.M. to respective Directorates who in turn submit to Directorate General Accounts & Treasuries by 1:30 P.M.
- f) Payments Authorized on 31.03.2023 are processed well in time to avoid last minute rush on various applications as per special arrangement put in place by RBI.
- g) Treasury Officers will not leave the treasuries unless successful information regarding acknowledge approved, debit notification is received from RBI.
- h) Any information regarding acknowledgement rejected, return notification for the payments processed on last day of Financial Year (if any) from RBI is communicated to respective DDO's / NIC well in time for correction/rectification.
