## Subject: - Ambassador and Champion Model for Nodal Offices implementing NPS.

In its endeavor to strengthen the implementation and operationalization of National Pension System (NPS), Pension Fund Regulatory & Development Authority (PFRDA) has decided to establish a process to recognize the valuable contribution of the Nodal Offices in operationalization of NPS in the State/UT government sector. The said process has been termed as "Ambassador and Champion Model for Nodal Offices implementing NPS in the State/UT Government Sector". Under the proposed modal, Director General Accounts & Treasuries (DGA&T), presently registered as Directorate of Treasury Administration (DTA) in NPS architecture, has been nominated as an Ambassador. Each DTA from among states of Union of India shall compete under the Champion model and scoring will be based on following list of parameters under NPS to qualify for becoming Champion in the said model:

- Reduction in Delay in PRAN Generation; Nil Credit PRANs; Non-IRA PRANs; number of PRANs without Nomination and Mobile Numbers and Errors in Fund Remittance.
- Increase in Subscriber Credit Coverage.
- Improvement in Turnaround Times for resolution of Grievances and processing & authorization of Exit/Withdrawal requests.

In view of the above, it is impressed upon all the Nodal Officers/Treasury Officers falling under Accounts & Treasuries Organization and State Autonomous Bodies (SABs) to contribute vehemently and overwhelmingly towards this exercise in order to increase our performance with regards to above mentioned NPS parameters under Ambassador and Champions Model.
