



**Subject: Consideration of officers from services other than those belonging to State Civil Service (KAS) for appointment by selection to the IAS of J&K Cadre.**

For appointment of non-SCS officers to the IAS of J&K cadre, by selection in terms of IAS (Appointment by Selection) Regulations, 1997, two vacancies have been determined for the year, 2013.

The undersigned is directed to request the Principal Secretary / Commissioner / Secretary to Government, Finance Department to kindly recommend suitable officer (s) (in the prescribed proforma) of the Service (s) managed by the Department who fulfill the conditions of eligibility for consideration of their appointment to IAS by selection.

It may be mentioned that in terms of Rule (4) of the Indian Administrative Service (Appointment by Selection) Regulations, 1997, a person who does not belong to the State Civil Service (KAS) shall be eligible for consideration for appointment to IAS by selection provided he

- :-
- (i) is of outstanding merit and ability;
  - (ii) holds a gazetted post in a substantive capacity;
  - (iii) has completed not less than eight years of continuous service under the State Government as on 1<sup>st</sup> January, 2013 in any post which has been declared equivalent to the post of Deputy Collector in the State Civil Service (Rs. 7500-12000 - pre-revised).

Further:

- (i) a person who has attained the age of 54 years on the 1<sup>st</sup> January, 2013 shall not be eligible for consideration; and
- (ii) a person who, having been included in an earlier select list but was not appointed by the Central Government, shall not also be eligible for consideration.

Since the exercise for short-listing of officers is time bound, it is requested that the recommendations be forwarded to GAD by 21<sup>st</sup> August, 2013 positively after which no nomination shall be entertained. Cases incomplete in any respect will also not be entertained. It is further requested that full dossier APRs of the officer (s) since appointment till date complete in all respects i.e. duly initiated / reviewed / accepted by the concerned authorities <sup>and posting details</sup> should also be sent with the proposal. The names of the officers should be recommended by the Administrative departments concern.
