Subject:- Contribution towards the 'Cancer Treatment and Management Fund for Poor'.

C I R C U L A R

Vide Circular instructions issued under endorsement No. DGAT/PS/DR/542 dated 07.07.2010 followed by No. DGAT/PS/DR/570 dated 22.07.2010 and No. DGAT/PS/DR/503 dated 23.06.2011, all the Drawing and Disbursing Officers were enjoined to effect deduction of ₹ 20/- and ₹ 10/- per month respectively from the Gazetted and Non-Gazetted employees, as contribution towards the 'Cancer Treatment and Management Fund for Poor', starting from the salary for the month of July, 2010 onwards. It was also instructed that should any of the employees object to such deduction, the amount so deducted shall be got refunded from the Managers of the Cancer Fund Account No. 01100102000000810 (CD 810).

2. Although the contribution is voluntary, yet the same being for a noble cause, is not expected to be objected to by any of the officers/ employees. Hopefully they should rather be contributing more generously even beyond the prescribed minima.

However, from the level of response enlisted, as evidenced from the quantum of contribution received in the Fund so far, it appears that the contribution on account of 'Cancer Treatment and Management Fund for Poor' is not being deducted regularly by the Drawing and Disbursing Officers, nor the Treasury Officers are ensuring implementation of the circular instructions issued by the Finance Department in this behalf, in the past.
4. All the Administrative Secretaries are, as such, once again requested to kindly impress upon the Drawing and Disbursing Officers to make regular deductions of ₹ 20/- and ₹ 10/- per month respectively from Gazetted and Non-Gazetted employees, as contribution towards the 'Cancer Treatment and Management Fund for Poor' and in the event of default in deduction in earlier months, and also in the case there is no objection from the employees, the same should now be deducted @ ₹ 240/- and ₹ 120/- or the outstanding due amount, as the case may be, to account for the balance contribution in one go, from the salary for the month of February, 2013 as large amounts are required for the treatment of poor cancer patients.
