Subordinate As: recommended bу the Services Recruitment Board, LAHDC, Leh vide communication referred to above, sanction is hereby accorded to the temporary appointment of 11 (Eleven) candidates indicated in Annexure-A to this order as Accounts Assistants (Apprentice) in the Accounts and Treasuries Organization Finance Department against the posts falling in District Leh (District Cadre) and are directed to report to Northern Zonal Accountancy Training Institute, Jammu for receiving one year's compulsory training (six month's theoretical and six month's practical). During the training period these candidates shall be entitled to stipend as admissible under rules.

After successful completion of one year's training at Northern Zonal Accountancy Training Institute, Jammu, they shall be formally placed as Accounts Assistants in the PB-1, ₹5200-20200 + Grade Pay ₹2800. They shall be governed in terms of New Recruitment Policy introduced vide Govt. Order No. 257-F of 2011 dated 27.10.2011 and adjusted in Leh District. Their service conditions shall be regulated under the provisions of "Rules for Admission in the Accountancy Training School for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".

The appointees shall report to the Principal Northern Zonal Accountancy Training Institute, Jammu within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- 1. Academic/Technical Qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by Competent Authority.

- 4. Permanent Resident Certificate.
- 5. Relevant Category Certificate.
- 6. Certificate from General Manger, DIC, Leh and Deputy Director Employment, Leh to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any appointee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The appointees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his/her Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his/her appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of Qualification Certificates/Reserved Category Certificates (wherever applicable) from the concerned issuing authority.

The stipend of the appointee shall not be drawn and disbursed to him/her unless a satisfactory report in respect of (a) and (b) above is received.
