

Consequent upon their selection by the J&K Services Selection Board, Jammu and as recommended by Relief & Rehabilitation Department vide communications referred to above, 40 candidates, listed in Annexure-A to this Order, are deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Accountancy Training Institute, Srinagar. During the training period they shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training at Accountancy Training Institute, Srinagar, they shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the post of Accounts Assistants and adjusted in their respective Home Districts (before migration) in the Kashmir Valley. They shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".

They shall be allowed to join and their joining report shall become effective only after they execute agreement in the "Form" prescribed in Annexure-B under Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rule 2009, introduced vide SRO 412 of 2009 dated 30.12.2009, besides production of the following certificates/documents in original:-





1. Academic/Technical Qualification Certificate.

2. Date of Birth Certificate.

3. Health Certificate issued by Competent Authority.

4. Permanent Resident Certificate.

5. Relevant Category Certificate.

6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

7. Migration Certificate of being a Kashmiri Migrant duly issued by Commissioner, Relief & Rehabilitation (Migrant),

Jammu.

In case the selectees fail to join within the stipulated period of 21 days, their selection shall stand cancelled without any further notice.

The appointment shall also be subject to the following conditions:-

- (a) The selectees shall give an undertaking in the shape of an Affidavit, duly authenticated by a Judicial Magistrate 1st Class, to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Principal concerned, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of Qualification Certificates/Reserved Category Certificates (wherever applicable) from the concerned Issuing Authority to be got done by the Principal concerned.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

In case any selectee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her selection/service shall stand terminated without any notice by itself by the action of his/her migration.


