The team shall study the model / procedure adopted by Government of Maharashtra to bring in uniformity and standardisation procedure / Data Structure of e-Receipts / e-Transaction of State Government as per recommendations of the Working Group of RBI. The team shall also study the model for implementation of Government Receipt Accounting System in J&K in order to establish Cyber Treasury in J&K and suggest amendments needed in the existing system of remittances and the relevant rules/orders required for its establishment.

The team shall submit its report along with recommendations within fortnight for further examination in the Finance Department.


