In case the selectees fail to join within the stipulated period of 21 days, their selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Principal concerned, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
