Subject: Regularization of Shri Romesh Chander, Assistant Accounts Officer, as a Member of Kashmir Subordinate Accounts Service, Class-I (Assistant Accounts Officers).

Reference: Jammu and Kashmir Public Service Commission's Notification No. PSC/Exam-2002/49 dated 15.07.2002.

Whereas, among others, Shri Romesh Chander, consequent upon qualifying SAC-II Examination vide J&K Public Service Commission's Notification referred to above, was placed as Incharge Assistant Accounts Officer vide Order No. 258-Acctts of 2007 dated 23.07.2007;

Whereas, among others, the case of the official was placed before the Departmental Promotion Committee in its meeting held on 23.07.2008 for his regularization as a member of Kashmir Subordinate Accounts Service, Class-I (Assistant Accounts Officers) but was deferred for want of Vigilance clearance;

Whereas, the case of the official was again placed before Departmental Promotion Committee for review/recommendations in its meeting held on 09.02.2012 which recommended him for adhoc promotion in terms of Article 110 (A) of J&K CSRs;

Whereas, on the recommendations of the Departmental Promotion Committee sanction was accorded to the adhoc promotion of the official in the Pay Band-2, ₹9300-34800+ Grade Pay ₹4600 in terms of Article 110 (A) of J&K Civil Service Regulation Rules vide Order No. 99 Accts of 2012 dated 09.02.2012;

Whereas, the Hon'ble Court of Special Judge Anti Corruption, Jammu in its decision dated 08.11.2010 acquitted the official of all the charges and the operative part of the order reads as under:-

*"Viewed thus the case is dismissed and accused are acquitted of all the charges leveled against them. Their bail bonds shall stand discharged".*



Whereas, the General Administration Department vide their letter No. GAD (Vig)08-Misc/2010 dated 16.10.2014 also intimated that the official stands acquitted on 08.11.2010 and the case stands consigned to records;

Whereas, in view of his acquittal by the Hon'ble Court his case for his formal regularization as a member of Kashmir Subordinate Accounts Service, Class-I (Assistant Accounts Officers), was placed before the Departmental Promotion Committee in its meeting held on 22.05.2014 but was again deferred for want of Integrity Certificate, APRs, and other relevant information from Director, Accounts & Treasuries, Jammu; and

Whereas, on receipt of the requisite documents from Director, Accounts & Treasuries, Jammu his case for regularization as Assistant Accounts Officer was again placed before the Departmental Promotion Committee in its meeting held on 26.12.2014 which recommended his regularization as a member of Kashmir Subordinate Accounts Service, Class-I (Assistant Accounts Officers) w.e.f. 27.07.2007 (i.e, the date from which his batchmates have been regularized) or actual date of assumption of charge as Incharge Assistant Accounts Officer whichever is later.

Now, in view of the above, Shri Romesh Chander, Assistant Accounts Officer, J&K State Power Development Corporation, Jammu is hereby formally regularized as a member of Kashmir Subordinate Accounts Service, Class-I (Assistant Accounts Officers) in the Pay Band-2, ₹9300-34800+ Grade Pay ₹4600 with effect from 27.07.2007 or actual date of assumption of charge as Incharge Assistant Accounts Officer whichever is later.


