Consequent upon their selection followed by release of recommendations by the J&K Services Selection Board, Srinagar vide communications referred to above, 04 candidates, listed in Annexure-A to this Order, are deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar as shown against each. During the training period they shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training at Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar, they shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the posts of Accounts Assistants. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".

The selectees shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- 1. Academic/Technical Qualification Certificate.
- 2. Date of Birth Certificate.

- 3. Health Certificate issued by Competent Authority.
- 4. Permanent Resident Certificate.
- 5. Relevant Category Certificate.
- 6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectees fail to join within the stipulated period of 21 days, their selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Principal concerned, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of Qualification Certificates/Reserved Category Certificates (wherever applicable) from the concerned issuing authority to be got verified by the Principal concerned.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.
