Whereas, among others, Shri Muhammad Ali Khan S/o Muhammad Hussain Khan R/o Panner Jagir Tral Pulwama and Shri Junaid Amin Bhat S/o Mohd Amin Bhat R/o Kanganhall Achabal Anantnag were recommended for selection as Accounts Assistants in Finance Department under ST Category and RBA Category in District Pulwama and District Anantnag in Main Selection List respectively by the Services Selection Board vide their Nos, referred to above with the condition that recommendations in respect of both these selectees were kept withheld and subject to production of valid Category Certificate and clarification from Competent Authority with regard to residence respectively;

Whereas, the Services Selection Board vide its Order Nos. 366-SBB of 2015 dated 13.08.2015 and 368-SSB of 2015 dated 18.08.2015, issued under endorsement Nos. SSB/Secy/ Secy/2015/7682-84 dated 13.08.2015 and SSB/Secy/Sel/ 2015/ 7743-45 dated 18.08.2015 respectively has cancelled/ withdrawn the selection of both these selectees ab-intio;

Whereas, due to cancellation of selection of these two selectees, two vacancies of Accounts Assistants became available under ST Category and RBA Category in District Pulwama and District Anantnag respectively; and

Whereas, consequent upon causing/availability of these two vacancies under ST Category and RBA Category in District Pulwama and District Anantnag, Shri Liyakat Nazir S/o Nazir Ahmad Khan R/o Bathnoor Jagir Tral Pulwama and Shri Syed Athar Ali Razvi S/o Syed Mushtaq Ahmad Razvi R/o Chittergul Achabal, Shangus, Anantnag, selected in the



Waiting List under ST Category and RBA Category in District Pulwama and District Anantnag by the Services Selection Board vide its Nos. referred to above, become entitled for deputation of one year's ACC training (six month's theoretical and six month's practical) in Accountancy Training Institute, Srinagar in place of Shri Muhammad Ali Khan S/o Muhammad Hussain Khan R/o Panner Jagir Tral Pulwama and Shri Junaid Amin Bhat S/o Mohd Amin Bhat R/o Kanganhall Achabal Anantnag.

In view of above and as approved by the Competent Authority, Shri Liyakat Nazir S/o Nazir Ahmad Khan R/o Bathnoor Jagir Tral Pulwama selected under ST Category in District Pulwama in Waiting List and Shri Syed Athar Ali Razvi S/o Syed Mushtaq Ahmad Razvi R/o Chittergul Achabal, Shangus, Anantnag selected under RBA Category in District Anantnag in Waiting List are deputed for one year's ACC training in Accountancy Training Institute, Srinagar (six month's theoretical and six month's practical). During the training period they shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training in Accountancy Training Institute, Srinagar, they shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".

The selectees shall report to the Principal, Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

(a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a



reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.

(b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.
