Deputation of Accounts Assistants (Apprentices), selected under Hon'ble Prime Minister's Special Package for Kashmiri Migrants, for undergoing Accounts Clerk's Course (ACC) Training.

Consequent upon their selection followed by release of recommendations by the J&K Services Selection Board, Srinagar vide communications referred to above, **04** candidates, listed in **Annexure-'A'** to this Order, are deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Accountancy Training Institute, Srinagar. During the training period they shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training at Accountancy Training Institute, Srinagar, they shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the posts of Accounts Assistants and adjusted in their respective Home Districts (prior to migration) in the Kashmir valley. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".

The selectees shall report to the Principal, Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order. They shall be allowed to join and their joining report shall become effective only after they execute agreement in the "Form" prescribed in **Annexure-'B'** under Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rule

2009, introduced vide SRO 412 of 2009 dated 30.12.2009, besides production of the following certificates/documents in original:-

- 1. Academic/Technical Qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by Competent Authority.
- 4. Permanent Resident Certificate.
- 5. Relevant Category Certificate.
- 6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.
- 7. Migration Certificate of being a Kashmiri Migrant duly issued by Commissioner, Relief & Rehabilitation (Migrant), Jammu.

In case any of these selectee fail to join within the stipulated period of 21 days, his/her selection shall stand cancelled without any further notice.

The appointment shall also be subject to the following conditions:-

- (a) The selectees shall give an undertaking in the shape of an Affidavit, duly authenticated by a Judicial Magistrate 1<sup>st</sup> Class, to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Principal concerned, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of Qualification Certificates/Migration Certificates/Reserved Category Certificates (wherever applicable) from the concerned Issuing Authority to be got done by the Principal concerned.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

In case any selectee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her selection/service shall stand terminated without any notice by itself by the action of his/her migration.

## AGREEMENT FORM

This Agreement is made on
through the Appointing Authority of the one part and Shrive-
residing at (hereinafter called as the Contracting Party) of the other part, and
Whereas, the Government has decided to provide employment to un-employed Kashmiri Migrant youth in terms of Rules, 2009.
Whereas, vide Government Order No dated in the executor has been appointed on probation as subject to execution of this Agreement, and inter-alia on the explicit condition that his selection as such shall subsist only so long as he/she serves in the Kashmir Valley;
Whereas, that the selectee shall be considered for regularization on the basis of his performance and satisfactory completion of period of probation in accordance with aforementioned rules;
Whereas, that the selectee agrees to serve in Kashmir Valley and will at no stage opt or seek for transfer outside Kashmir Valley
Whereas, the selectee agrees that in case he/she migrates again from Kashmir Valley at any stage for any reasons whatsoever, shall have no claim against any post under the State;
Whereas, if the selectee wilfully neglects or refuses to perform his/her duty in Kashmir Valley the Appointing Authority shall immediately terminate his/her service; and
Whereas, the selectee will at no stage seek or opt for transfer outside the Kashmir Valley.
Now, therefore, I accept the said terms and conditions of selection.
