Consequent upon his selection followed by release of recommendation by the J&K Services Selection Board, Srinagar vide communications referred to above, **Shri Sumesh Koul, S/o Jawahar Lal Koul R/o Jawahar Nagar, Talab Tilloo, Jammu** is deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Accountancy Training Institute, Srinagar. During the training period he shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training at Accountancy Training Institute, Srinagar, he shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the post of Accounts Assistant and adjusted in his respective Home Districts (prior to migration) in the Kashmir valley. His services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".

The selectee shall report to the Principal, Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order. He shall be allowed to join and his joining report shall become effective only after he execute agreement in the "Form" prescribed in **Annexure-'A'** under Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rule



2009, introduced vide SRO 412 of 2009 dated 30.12.2009, besides production of the following certificates/documents in original:-

- 1. Academic/Technical Qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by Competent Authority.
- 4. Permanent Resident Certificate.
- 5. Relevant Category Certificate.
- 6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.
- 7. Migration Certificate of being a Kashmiri Migrant duly issued by Commissioner, Relief & Rehabilitation (Migrant), Jammu.

In case the selectee fails to join within the stipulated period of 21 days, his selection shall stand cancelled without any further notice.

The appointment shall also be subject to the following conditions:-

- (a) The selectee shall give an undertaking in the shape of an Affidavit, duly authenticated by a Judicial Magistrate 1st Class, to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Principal concerned, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of Qualification Certificate/Migration Certificate/Reserved Category Certificate (wherever applicable) from the concerned Issuing Authority to be got done by the Principal concerned.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

In case the selectee migrates from Kashmir Valley at any time during his service tenure, for any reason whatsoever, his selection/service shall stand terminated without any notice by itself by the action of his migration.
