Subject: Grant of Higher Standard Pay Scale(s) to the Members of Kashmir Subordinate Accounts Service.

Reference: Recommendations/Minutes of the meeting of Departmental Promotion Committee of Accounts & Treasuries Organization.

**Dated : 11 . 06 . 2014**

Whereas Shri Jagdev Singh Salathia, Ex-Accounts Assistant, District Treasury Udhampur was granted 1<sup>st</sup> and 2<sup>nd</sup> HSPS(s) w.e.f. 01.01.1995 by Senior Superintendent of Police, Udhampur vide his office Order issued under endorsement No. SSP/619-21/99 dated 21.06.1999;

Whereas Senior Superintendent of Police, Udhampur vide his No. Estt/17188-89 dated 23.08.2003 requested for confirmation/regularization of the Higher Standard Pay Scale(s) already granted in favour of the Ex-Accounts Assistant by the Police Department as he was not competent to grant HSPS(s) to the Ex-Accounts Assistant;

Whereas the then Deputy Director, Accounts & Treasuries, Jammu vide his No. DDATJ/624 dated 22.01.2004 requested the Senior Superintendent of Police, Udhampur to submit the case of the Ex-Accounts Assistant for regularization of his INSITU promotions after proper re-fixation of his pay;

Whereas Senior Superintendent of Police, Udhampur vide his Order No.876 of 2004 dated 28.07.2004 cancelled the HSPS(s), granted by him in favour of the Ex-Accounts Assistant and also recovered the amount of Rs.1,61,538/- accrued to him on this account;

Whereas instead of withdrawing 1<sup>st</sup> and 2<sup>nd</sup> HSPS(s) from the Ex-Accounts Assistant, the action taken by the Senior Superintendent of Police, Udhampur should have been got confirmed by the Competent Authority as viewed by the DPC in its meeting held on 23.01.2014;

Whereas the case has been got examined by the Director, Accounts & Treasuries, Jammu afresh and it revealed that the same has remained under correspondence with Senior Superintendent of Police, Udhampur since 2004;

Whereas Director, Accounts and Treasuries, Jammu vide his No. DATJ/Adm/J-12A/A/2013-14/7375-77 dated 30.11.2013 recommended

the case of Ex-Accounts Assistant for grant of all the three HSPS(s) in his favour and the case was placed before the DPC in its meeting held on 23.01.2014 who recommended that the case may be re-examined before taking any decision in the matter;

Whereas the case of the Ex-Accounts Assistant was re-examined in context of the details given by the Director, Accounts & Treasuries, Jammu in his letter No. DATJ/Adm/J-12A/A/2013-14/7375-77 dated 30.11.2013 and it was decided to place the case again before the DPC in its ensuing meeting;

Whereas the case of the Ex-Accounts Assistant was accordingly again placed before the DPC in its meeting held on 22.05.2014 who recommended to grant all the three HSPS(s) in favour of the retired official monetarily from the dates of their admissibility.

Now, therefore, in terms of SRO 14 dated 15.01.1996 and as recommended by the Departmental Promotion Committee, sanction is accorded to the grant of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> HSPS(s) in favour of Shri Jagdev Singh Salathia, Ex-Accounts Assistant, District Treasury Udhampur from the dates indicated against each:-

**Consequent upon grant of HSPS(s), their Pay Fixation and Pay/Pension Arrears, admissible from the Date(s) the HSPS(s) has/have been granted, shall be regulated strictly in accordance to the Provisions laid down in SRO-94 dated 23.03.2007, SRO 93 dated 15.04.2009, SRO 222 dated 10.07.2012 read with O.M. No. A/70(09)-1070 dated 28.08.2012 and Govt. Order No. 238-F of 2011 dated 30.09.2011 read with SRO-42 dated 02.02.2011 and O.M. No. A/106(96)-1-614 dated 19.12.2011 and Govt. Order No. 08-F of 2012 dated 05.01.2012.**


