As recommended by the J&K Services Selection Board Jammu vide communications referred to above and clarification issued vide No. SSB/Sel/Secy/014/5879-80 dated 09.07.2014, sanction is hereby accorded to the deputation of **12 (Twelve)** Accounts Assistants (Apprentices), indicated in Annexure – A to this order, to Accountancy Training Institute, Srinagar, for one year's A.C.C. training (six month's theoretical and six month's practical). During the training period these candidates shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training at Accountancy Training Institute, Srinagar they shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800 and shall be entitled to fixed salary mode in terms of Govt. Order•No. 257-F of 2011 dated 27.10.2011. Their services shall be regulated under the "Rules for Admission in the Accountancy Training School for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".

The selectees shall report to the Principal, Accountancy Training Institute, Srinagar within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- 1. Academic/Technical Qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by Competent Authority.
- 4. Permanent Resident Certificate.
- 5. Relevant Category Certificate.



 Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of Qualification Certificates/Reserved Category Certificates (wherever applicable) from the concerned issuing authority.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.
