Whereas, Joint Secretary, Verification, J&K State Board of School Education, Srinagar vide No. F(JS-Ver)B/KD/2022/F-3224//3216/ASV dated 26.09.2022 has verified the date of birth of Sh. Khurshid Ahmad Shah S/O Ab. Samad Shah as 01.04.1962, and have certified that the original certificate be treated as genuine provided it does not bear any mutilation, insertion, erasing or overwriting.
