- v. Certificates from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under self employment scheme has been taken by the appointee.

The appointment of the appointee, shall further be subject to the following conditions:-.

- a) That he shall give an undertaking in the shape of an Affidavit to the effect that:
 - i. In case adverse report about his Character and Antecedents is received from the Additional Director General of Police, (CID), J&K, to whom a reference shall be made by the Director, Accounts & Treasuries Jammu, he shall have no right to claim his appointment as Orderly in the Accounts & Treasuries Organization and his appointment, as such, shall be deemed to have been cancelled ab-initio;
 - ii. If, on verification, genuineness of the qualification certificate from the concerned issuing authority is found fake/ forged, the claim of the appointee for appointment as Orderly shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b) The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory report in respect of (i) and (ii) above are received in his favour.

- c) The appointee shall be initially on probation for a period of two years.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- e) If the appointee fails to join within a period of 21 days from the issuance of this order he shall forego to his right to his appointment which shall be deemed to have been cancelled ab-initio within any further notice.
