Sanction is hereby accorded to the temporary appointment of Smt. Komal Kumari D/o Swarn Singh and W/o Late Sh. Vikas Bharti (Ex- Accounts Assistant) R/o Village Arnia, Tehsil Arnia, District Jammu as MTS in the Pay Level SL-1(14800-47100) in Finance Department (Accounts & Treasuries Organization) on compassionate grounds under SRO-43 of 1994.

The appointee shall report to the Director Accounts & Treasuries, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of following documents/certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. Valid relevant Category Certificate, if any, applicable.
- vii. All other relevant documents as are required under SRO-43/1994.

The appointment of the candidate shall further be subject to the following conditions:-

- a. That she shall give an undertaking in the shape of an Affidavit to the effect that if her qualification certificate(s), on verification, from the concerned issuing authorities is/are found fake/forged, her claim for appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- b. That if the candidate has taken loan for self employment from DIC/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such the self-employment unit/enterprise before joining

Government service. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- c. The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory report in respect of (a) above is received in her favour.
- d. The appointee shall be on probation for a period of two years.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009 as amended from time to time.
- f. If the appointee fails to join within a period of 21 days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.


