The appointee shall report to the Director Accounts & Treasuries, Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of following documents/certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. Certificates from the District Industries Center (DIC) and District Employment & Counseling Center to the effect that no loan under self employment scheme has been taken by the appointee.
- vii. All other relevant documents as are required under SRO-43/1994.

The appointment of the candidate shall further be subject to the following conditions:-

- a. That he shall give an undertaking in the shape of an Affidavit to the effect that if, the qualification certificate on verification from the concerned issuing authority is found fake/forged, the claim of the (candidate) for appointment as Multitasking Staff (MTS) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory report in respect of (a) above is received in his favour.

- e. If the appointee fails to join within a period of 21 days from the issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
