C I R C U L A R

All the Gazetted Officers of Accounts & Treasuries organization may refer this Office Notification No. DGAT/SPARROW/2022-23/54 dated: 01.06.2023 (copy enclosed) wherein it was asked to furnish the requisite information in the prescribed format for generation of blank PARs for the Financial Year 2022-23 (1st April, 2022 to 31st March, 2023) on SPARROW portal. However, it has been observed that a sizeable number of Officers have not furnished information due to which their blank APRs on SPARROW portal could not be generated. The higher authorities have taken a serious note of it.
