Whereas, the **18 selectees**, listed in **Annexure - A**, to this order, among others, recommended by the Services Selection Board for appointment against the posts of Accounts Assistants vide their Nos. referred to above, were deputed for undergoing one year's ACC training vide Order No. 10-Acctts of 2017 dated **11.01**.2017;

Whereas, they were supposed to join in Northern Zonal Accountancy Training, Institute, Jammu / Accountancy Training Institute, Srinagar by 1st of February, 2017;

Whereas, as intimated by the Principal, Northern Zonal Accountancy Training, Institute, Jammu/Accountancy Training Institute, Srinagar vide their Nos. A/Zonal/J/2017/21-22 dated DB.02.2017 and ATIS/017/1337 dated 08.02.2017 respectively, these selectees failed to join in the respective training Institutes within the stipulated period;

Whereas, a notice was issued vide No. DGAT/E-III/G-21/48 dated 10.03.2017 through print media and official website informing the concerned selectees/absentee that consequent upon their failure to join/report in the concerned training Institutes, their selection shall be cancelled and the Waiting Lists furnished by the Services Selection Board shall be operated in their places. These selectees/absentee were also given a chance to file their objections, if any, to this effect within seven days from the date of issuance of the aforementioned notice;

Whereas, out of these 18 absentee, 02 candidates, namely, Shri Shivan Sharma S/o Sham Lal Sharma R/o Serh Akknoor Jammu and Shri Retash Anand S/o Om Parkash Anand R/o Sian Mahadev Udhampur, figuring at Serial Nos. 07 & 13 in

Annexure-A, to this Order, responded to the aforementioned notice vide their Applications, both dated 15.03.2017, requesting therein to allow them to join in the training Institute as they had failed to report in the training Institute within the stipulated period due to their ailing health and their cases have been processed separately;

Whereas, the selection of remaining 16 absentee and the order of their deputation for one year's ACC training in NZATI, Jammu/ATI, Srinagar needs to be cancelled and in their place the candidates recommended by the Services Selection Board in the Waiting Lists under relevant categories of concerned Districts vide their Nos. referred to above, are required to be deputed for one year's ACC training in NZATI, Jammu/ATI, Srinagar;

In view of above, sanction is hereby accorded to the:-

cancellation of selection/deputation for one year's ACC training in respect of **16 candidates**, listed in **Annexure-'B'** to this order, who failed to join in the training Institute within the stipulated period and were selected by the Service Selection Board as Accounts Assistants in Finance Department in the Main Selection Lists under different Categories in different Districts vide its Nos. referred to above; and

deputation of 11 candidates, listed in Annexure-'C' to this order, selected by the Service Selection Board as Accounts Assistants in Finance Department in Waiting Lists under relevant Categories in concerned Districts vide its Nos. referred to above, for one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu / Accountancy Training Institute, Srinagar, indicated against each.

During the training period they shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training Institute, Jammu/ Accountancy Training Institute, Srinagar, they shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".

The selectees shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu / Accountancy Training Institute, Srinagar, within a period of 21 days from the date of

issuance of this order alongwith the following certificates/documents in original:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.
