Subject:- Cancellation of type test conducted vide notification No:DGAT/HQ/EM/148 dated 22-02-2018.

Government Order No: → F of 2018 Dated 7 -09-2018

Whereas, the Department conducted a Type Test for the promotion of orderlies as I/C Junior Assistants under promotion quota in terms of notification No: DGAT/HQ/EM/148 dated 22-02-2018;

Whereas, the records reveal that no post of Junior Assistant was available under promotion quota at the time of issuance of notification dated 22-02-2018, as the promotion quota had already got exhausted and exceeded by 05 posts;

Whereas, in terms of SRO 186 dated 08-07-2009 issued by GAD, the promotion quota between direct recruits and promotees has to be maintained in the ratio of 75:25 and GAD on consultation vide their U.O.No.GAD9Adm) 100/2018-IV dated 06-06-2018 also advised to maintain the sanctioned strength strictly in terms of recruitment rules adopted by the inter-organizational setup of Finance Department;

Whereas, in absence of any Recruitment Rules, the Department in order to enable to effect promotion to its Ministerial Staff, from time to time, adopted the Jammu & Kashmir Secretariat (Subordinate) Service Recruitment Rules, 2009;

Whereas, notification dated 22-02-2018 typing speed of 35 words per minute was prescribed in contravention of norms fixed by the GAD i.e. 25 words per minute;

Whereas, as per aforementioned notification dated 22-02-2018, merit obtained in the type test has been the criteria for promotion as I/C Junior Assistant in contravention of the Jammu & Kashmir Secretariat (Subordinate) Service Recruitment Rules, 2009, which provides for promotion in order of seniority;

Whereas, the above referred notification dated 22-02-2018 came to be issued in violation of provisions laid down in SRO 186 dated 08-07-2009 for maintenance of quota in the ratio of 75:25;

Whereas, given the fact that no Junior Assistant post was available with the Department under promotion quota at the time of issuance of notification dated 22-02-2018 and the notification was issued without ascertaining availability of posts in violation of rules, the notification issued has been, therefore, invalid and void ab-intio.

Now, therefore, in view of above facts and circumstances, it is hereby ordered that the notification issued by the Department vide No. DGAT/HQ/EM/148 dated 22-02-2018 shall be treated void ab-intio and consequent upon which the type test conducted/merit list framed in respect of orderlies pursuant to said notification is hereby cancelled.
