Sub: Appointment against the post of Data Entry Operator in Finance Department Under SRO 202 State Cadre/Divisional Cadre Kashmir.

Ref: Secretary, J&K Services Selection Board, Jammu's letter No. SSB/Secy/Sel/2018/3109-15 dated 23.03.2018.

Whereas, Services Selection Board, Jammu vide their No. referred to above among others, recommended selection of **Mr. Altaf Hussain Dar S/o Ab. Khaliq Dar R/o Achan, Pulwama**, against the post of Data Entry Operator **under OM, Category** in State Cadre/ Divisional Cadre, Kashmir.

Whereas, the selectee vide Government Order No. 272- F of 2018 dated 05.06.2018 was appointed as Data Entry Operator and posted in District Treasury, Pulwama.

Whereas, the appointee was supposed to join in District Treasury Pulwama within a period of 21 days from the date of issue of the aforementioned order.

Whereas, Director Accounts and Treasuries, Kashmir vide his No. DATK/Adm-II/PF-DEO/13669 dated 12.11.2018 communicated that the appointee failed to join in District Treasury, Pulwama within the stipulated period of 21 days.

Whereas, a notice vide No. DGAT/HQ/EM/257 dated 29.11.2018 was served to the absentee informing him that due to his non joining within the stipulated time, his appointment shall be cancelled and objection, if any, to this effect may be brought to the notice within seven days from the date of issuance of the aforementioned notice.

Whereas, Director Accounts and Treasuries, Kashmir vide his No. DATK/Adm-II/DEO/15682 dated 19.12.2018 has communicated that the appointee has not filed any objection in this behalf within the stipulated period.

In view of the above sanction is here by accorded to the:-

- i. cancellation of selection/appointment of Mr. Altaf Hussain Dar, S/O Ab. Khaliq Dar, R/O Achan Pulwama, Kashmir who has failed to join in District Treasury, Pulwama, within the stipulated period.
- ii. appointment of **Shri Sumit Birdi S/O Bushan Lal Birdi R/O New Plot, Jammu**, appearing at S.No. 01 of Wait List under OM category issued by Service Selection Board vide their above referred letter No. as Data Entry Operator in Accounts & Treasuries Organization in Pay Band of Rs. 5200-20200 + Grade Pay 1900/- (Pre-revised)/ Level- 2 (Rs. 19900-63200) (Revised) state Cadre/Divisional Cadre, Kashmir.

The appointee shall report in the office of the Director General, Accounts & Treasuries, J&K within a period of 21 days from the date of issuance of this order alongwith the following certificates/ documents in original:-

- i. Academic/Technical Qualification Certificates.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that no loan under self employment Scheme has been taken by the appointee.

The appointment shall be subject to the following conditions:-

- a) The appointee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his character and antecedents is received from the Additional Director General Of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- b) The verification of all required Certificate viz, Academic qualification certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that no loan under self employment Scheme has been taken by the appointee from the concerned issuing Authority to be got don by the concerned Head of office.
- c) The appointment of the candidate shall be governed by the provisions of SRO 202 dated 30.06.2015.
- d) His inter-se-seniority shall be in order in which his name appear in the Government order which is according to the select list furnished by the Service Selection Board.
- e) The salary of the appointee shall not be drawn and disbursed until and unless a satisfactory report in respect of (a) & (b) above are received in his favour.

In case appointee does not join within the stipulated period of 21 days his appointment shall be deemed to have been cancelled ab-initio without any further notice.
