## **Notice**

The Department is in process to regularize I/C Accounts Officers as Junior Scale Accounts Officers in terms of the Jammu and Kashmir Accounts (Gazetted) Service Rules, 1972 read with amendments issued thereto by the Government from time to time, for which Vigilance Clarence is required to be obtained from General Administration Department(Vig) to assess the credentials of the eligible officers.

In order to seek requisite clearance from the Vigilance Organization through GAD(Vig), I/C Accounts Officers listed in **Annexure-"A"** to this Notice are requested to furnish their complete bio-data along with complete Posting Details right from their initial appointment in the Government Service(s) till date (in original) through the Heads of offices/Controlling Officers together with APRs for the last **05 years**, by or before **10<sup>th</sup> of December, 2018** positively, failing which, their promotion shall be put on hold without any further notice. The Service bio-data may be furnished in accordance to the instructions laid down in Circular No. 11 of GAD(Vig) of 2018, dated 10.04.2018, issued under endorsement No. GAD(Vig) 06-Adm/2014 dated 10.04.2018 (Copy annexed for ready reference as **Annexure"B"**) to enable the Department to take timely action in the matter.
