Whereas, among others, Secretary, Services Selection Board, J&K vide No. SSB/Secy/Sel/2016/1849A-4 dated 04.07.2016 furnished the Main Select List of **28 candidates** (OM=16, RBA=06, SC=02, OSC=01 & ST =03) for the posts of Accounts Assistants alongwith Waiting List of **08 candidates** (OM=05, SC=01, OSC=1, ST=01) for District Kathua.

Whereas, vide this office Order No. 198-Acctts of 2016 dated 06.09.2016 these selectees were deputed for undergoing one year's ACC training in NZATI, Jammu except Shri Sanjeev Kumar, Shri Nitan Gupta Shri Sunny Kumar and Shri Manjeet Singh under OM Category and **Shri Yogal under SC Category** as their recommendations were kept withheld by the Services Selection Board.

Whereas, the recommendation in respect of one Shri Yogal, S/o Yesh Pal, R/o Bhalra Doda selected under SC category in District Kathua was released by the SSB vide their No. SSSB/Sel/ Secy/ 2016/19875-77 dated 28.09.2016 and he was subsequently deputed for undergoing one year's ACC training vide Order No. 231-Acctts of 2016 dated 20.10.2016.

Whereas, the Principal NZATI, Jammu vide No. A/Zonal/J/2016/1109-10 dated 15.11.2016 intimated that Shri Yogal, S/o Yesh Pal, R/o Bhalra Doda selected under SC category in District Kathua did not join in the Institute.

Whereas, in the meantime Shri Rajinder Kumar S/o Shri Kala Ram R/o Changran Kathua made a representation wherein he requested for considering his appointment against the post of Accounts Assistant in District Kathua under SC Category from the Waiting List.



Whereas, a notice vide No. DGAT/E-III/G-21/73 dated 20.04.2017 was served to Shri Yogal, S/o Yesh Pal, R/o Bhalra Doda selected under SC category in District Kathua to submit his objection, if any regarding cancellation of his selection and the said notice was published in "Himalayan Mail" a local daily in jammu.

Whereas, the candidate did not file any objection in this behalf within a stipulated period of seven days.

In view of above, sanction is hereby accorded to the:-

- (i) Cancellation of the selection of Shri Yogal, S/o Yesh Pal, R/o Bhalra Doda selected under SC category in District Kathua; and
- (ii) deputation of Shri Rajinder Kumar S/o Shri Kala Ram R/o Changran Kathua for undergoing one year's ACC training in NZATI, Jammu.

During one year's ACC training the candidate/selectee shall be entitled to stipend as admissible under rules.

The selectee shall report to the Principal, Northern Zonal Accountancy Training, Institute, Jammu within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

(a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.



The verification of all required certificate viz; Academic (b) Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu, he shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800. His services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
