

Sub: Deputation of Accounts Assistant (Apprentice) for one year's ACC Training.

Whereas, among others, Ms. Jasdeep Kour, D/O Shri Amarjeet Singh, R/O Miran Sahib R.S. Pora Jammu was selected as Accounts Assistant (Apprentice) in District Jammu in Waiting List under OM Category by the J&K Services Selection Board vide their No. referred to above;

Whereas, recommendation in respect of the candidate was kept withheld by the Services Selection Board subject to clarification from Competent Authority with regard to residential district; and

Whereas, the Secretary, J&K Services Selection Board vide his letter No. SSB/Sel/Secy/2017/4563-65 dated 26.04.2017 has conveyed that the recommendation which was kept withheld in respect of the above said candidate is now released in her favour.

Consequent upon release of recommendation by the J&K Services Selection Board vide their communication referred to above, Ms. Jasdeep Kour, D/O Shri Amarjeet Singh, R/O Miran Sahib R.S. Pora Jammu is deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Northern Zonal Accountancy Training Institute, Jammu. During the training period she shall be entitled to stipend as admissible under rules.

The selectee shall report to the Principal, Northern Zonal Accountancy Training Institute, Jamiqu, within a period

of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- 1. Academic/Technical Qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by Competent Authority.
- 4. Permanent Resident Certificate.
- 5. Relevant Category Certificate.
- 6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, her selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about her Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, her appointment shall itself stand cancelled ab-initio and she shall have no claim of her appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate, Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training at Northern Zonal Accountancy Training Institute, Jammu, she shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the post of

Accounts Assistant. Her services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".
