Sub: Deputation of Accounts Assistants (Apprentices) for A.C.C. Training.

Ref: Secretary J&K Service Selection Board, Srinagar's letter No:- SSB/Secy/Sel/2016/20258-64 dated 18.11.2016.

Whereas, among others, Secretary, Services Selection Board, J&K vide their No. referred to above forwarded Selection List of 16 candidates (OM=09, RBA=3, SC=1, OSC=1, ST=2) alongwith Waiting List of 07 Candidates (OM=03, RBA=1, SC=1, OSC=1, ST=1) for District Doda;

Whereas, vide Order No. 10-Accts of 2017 dated 11.01.2017, out of these 16 candidates, only 10 candidates (OM=06, RBA=1, SC=1, ST=2) were deputed to Northern Zonal Accountancy Training Institute, Jammu, for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical);

Whereas, the remaining 06 candidates (OM=3, RBA=2 & OSC=1) were deputed to NZATI, Jammu vide this Office Order Nos:- 40-Accts of 2017 dated 09.02.2017, 76-Accts of 2017 dated 06.04.2017, 68-Accts of 2017 dated 27.03.2017 for undergoing one year's ACC Training in NZATI, Jammu;

Whereas, Shri Sumit Raina S/o Shri Pishori Lal Raina R/o Mohalla Doda vide his representation dated 24.04.2017 requested for considering his appointment against the post of Accounts Assistant in District Doda under OM Category as Shri Yogal, S/o Yesh Pal, R/o Bhalra Doda who was deputed for undergoing one year's ACC training in NZATI, Jammu vide Order No. 68-Accts of 2017 dated 27.03.2017 has not joined in NZATI, Jammu as he is figuring at Serial No. 01 in the Waiting List under OM Category in District Doda;

Whereas, a notice vide No. DGAT/E-III/G-21/98 dated 15.06.2017 was served to Shri Yogal, S/o Yesh Pal, R/o Bhalra Doda selected under OM category in District Doda to submit his objection, if any regarding cancellation of his selection; and

Whereas, the concerned candidate has not filed any objection in this behalf within stipulated period of seven days.

In view of above, sanction is hereby accorded to the:-

- i. cancellation of selection/deputation for one year's ACC training in respect of Shri Yogal, S/o Yesh Pal, R/o Bhalra Doda selected under OM category in District Doda who failed to join in the training Institute within the stipulated period; and**
- ii. deputation of Shri Sumit Raina S/o Shri Pishori Lal Raina R/o Mohalla Doda to NZATI, Jammu selected by the Service Selection Board as Accounts Assistant in Finance Department in Waiting List under relevant Category in concerned District vide its No. referred to above, for undergoing one year's ACC training in Northern Zonal Accountancy Training Institute, Jammu.**

During one year's ACC training the selectee shall be entitled to stipend as admissible under rules.

The selectee shall report to the Principal, Northern Zonal Accountancy Training, Institute, Jammu to this Order, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his

appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.

- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu, he shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. His services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
