Consequent upon qualifying SAC-I Examination vide J&K Public Service Commission's Notification No. referred to above and as recommended by the Departmental Promotion Committee in its meeting held on 27.12.2017, sanction is accorded to the regularization of **45** (Forty Five) Incharge Accountants as Members of Jammu and Kashmir Subordinate Accounts Service, Class-II (Accountants) in the Pay Band-2, ₹9300-34800+ Grade Pay ₹4220 with effect from the dates indicated against each in Annexure "A" to this order.

Two (02) I/C Accountants figuring at Serial Nos. 06 and 21 who have been appointed in Finance Department under Hon'ble Prime Minister's Special Package for Return & Rehabilitation of Kashmiri Migrants to Kashmir Valley, have been regularized against the posts of Accountants by corresponding reduction of equal number of supernumerary posts of Accounts Assistants allotted to the Department.

The regularization of these officials shall be without prejudice to the seniority of the Incharge Accountants who could not be regularized for administrative reasons and shall be subject to outcome of the writ petition(s), if any, pending before any Court of Law or any order already passed but not brought to the notice of the Departmental Promotion Committee.

Their inter-se-seniority shall be determined separately.
