Whereas, the Secretary, Services Selection Board, Jammu vide Nos. SSB/Sel/Secy/2018/4723- 25 dated 25.04.2018 conveyed that recommendations in favour of the said selectee is released;

Consequent upon release of recommendations by the J&K Services Selection Board, the selectee is deputed for undergoing one year's ACC training in Northern Zonal Accountancy Training Institite, Jammu.

The selectee shall report to the Principal, NZATI, Jammu within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fail to join within the stipulated period of 21 days, his selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the

Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.

b) The verification of all required certificate viz; Academic Qualification Certificates, Date of Birth Certificates, Health Certificates, Permanent Resident Certificates, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training at NZATI, Jammu he shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 (Pre-revised)/ Level-5 (29200-92300) against the post of Accounts Assistants. His services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".
