Sub: Deputation of Accounts Assistants (Apprentices) for A.C.C. Training.

Ref: Secretary J&K Service Selection Board, Srinagar's letter No:- SSB/Secy/Sel/20168/809-15 dated 17.01.2018 .

Whereas, among others, The J&K Service Selection Board vide No. referred to above issued the selection list/ waiting list of **44** Accounts Assistants (apprentices) for District Cadre Anantnag, Budgam, Pulwama and Kupwara.

Whereas, recommendations of these Candidates were kept withheld for want of certain documents,

Whereas, SSB vide order No. **482 SSB of 2018 dated 20.11.2018** cancelled selection of these **44 candidates** as void ab-initio (**43 from the main selection list and 1 from waiting list whose waiting position was cleared due to non-joining of candidates in District Kupwara under OM Category**).

Whereas, **against these 44 Candidates (Kupwara= 17, Budgam= 11, Pulwama= 12 and Anantnag= 04)** only **39 candidates (Kupwara= 16, Budgam= 10, Pulwama= 10 and Anantnag= 03)** are available in the waiting list in the relevant categories.

Whereas, Clear cut recommendation has been furnished by the SSB in favour of **only 28 candidates (Kupwara= 11, Budgam= 05, Pulwama= 09 and Anantnag= 03) listed in annexure "A"** to this order.

In view of above, sanction is hereby accorded to the:-

Deputation of 28 candidates, listed in Annexure-'A' to this order, selected by the Service Selection Board as Accounts Assistants in Finance Department in Waiting Lists under relevant Categories in concerned Districts Cadre vide its No. referred to above, for one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu/ Accountancy Training, Institute, Srinagar.

During one year's ACC training the candidate shall be entitled to stipend as admissible under rules.

The selectee shall report to the Principal, Northern Zonal Accountancy Training, Institute, Jammu/ Accountancy Training, Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, her appointment shall itself stand cancelled ab-initio and she shall have no claim of his appointment.
- (b) The verification of all required certificate (s) viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to her/him unless a satisfactory report in respect of (a) and (b) above is received.



After successful completion of one year's ACC training in Accountancy Training, Institute, Srinagar They shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800 (Pre-reserved)/ Level-5 (29200-92300). Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".




