Wheras, among others, The J&K Service Service Board vide No. referred to above issued the selection list of **05** Accounts Assistants (apprentices) for District Cadre Kupwara and Anantnag.

Whereas, recommendations of these Candidates were kept withheld for want of certain documents,

Whereas, SSB vide order No. 505-SSB of 2018 dated 31.12.2018 and 01-SSB of 2019 dated 01.01.2019 cancelled selection of these 05 candidates as void ab-initio.

Whereas, against these 05 Candidates (Kupwara= 04, and Anantnag= 01), 05 candidates are available in the waiting list.

Whereas, Clear cut recommendation has been furnished by the SSB in favour of **only 03 candidates (Kupwara= 02 Anantnag= 01)**.

In view of above, sanction is hereby accorded to the:-

Deputation of 03 candidates, listed in Annexure-'A' to this order, in Districts Kupwara and Anantnag under OM Category (waiting List), for one year's ACC training in Accountancy Training Institute, Srinagar.

During one year's ACC training the candidate shall be entitled to stipend as admissible under rules.

The selectee shall report to the Accountancy Training, Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate (s) viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to her/him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Accountancy Training, Institute, Srinagar They shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800 (Preresived)/ Level-5 (29200-92300). Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
