Wheras, among others, The J&K Service Service Board vide No. referred to above recommended selection of Sh. Aabid Hussain Khan S/o Assad Ullah Khan R/o Bonigam Quazigund District Cadre Kulgam under O.M category.

Whereas, recommendation of the selectee was kept withheld for want of certain documents,

Whereas, SSB vide order No. 463-SSB of 2018 dated 25.10.2018 cancelled selection of the above mentioned candidates as void ab-initio.

Whereas, against the vacancy caused by the cancellation of selection of Sh. Aabid Hussain Khan S/o Assad Ullah Khan R/o Bonigam Quazigund, one Candidate namely **Ishfaq Hafiz Wani S/o Hafiz Ullah Wani R/o Chowgam Kulgam** recommended by the SSB in the waiting list at S. No. 06 in the relevant category becomes eligible for his deputation for one year's ACC training.

Whereas, the candidates figuring from S.No 01 to 05 in O.M category stands already deputed for one year's ACC training to ATI, Srinagar.

Whereas, recommendation in favour of Ishfaq Hafiz Wani S/o Hafiz Ullah Wani R/o Chowgam Kulgam was kept withheld by the Services Selection Board for want of certain documents.

Whereas SSB vide No. SSB/Secy/Sel/245/2017/6046-49 dated 14.06.2018 has released withheld recommendation in favour of Ishfaq Hafiz Wani S/o Hafiz Ullah Wani R/o Chowgam Kulgam.

In view of above, sanction is hereby accorded to the:-

deputation of Ishfaq Hafiz Wani S/o Hafiz Ullah Wani R/o Chowgam Kulgam for undergoing one year's ACC in the

Accountancy Training Institute, Srinagar, selected by J&K SSB for the post of Accounts Assistantin in Finance Department.

During one year's ACC training the candidate shall be entitled to stipend as admissible under rules.

The selectee shall report to the Principal, Accountancy Training, Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, her appointment shall itself stand cancelled ab-initio and she shall have no claim of his appointment.
- (b) The verification of all required certificate(s) viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointees from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Accountancy Training Institute, Srinagar, he shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800 (Preresived)/ Level-5 (29200-92300). His service shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
