Consequent upon release of recommendation by the J&K Services Selection Board, the above selectee is deputed for undergoing one year's ACC training in the Northern Zonal Accountancy Training Institute, Jammu.

The selectee shall report to the Principal, NZATI, Jammu within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- Date of Birth Certificate.
- Health Certificate issued by Competent Authority.
- Permanent Resident Certificate.
- 5. Relevant Category Certificate.
- Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of their appointment.
