Whereas, among others, the **08 selectees**, listed in **Annexure**"A" to this Order, recommended by the Services Selection Board for appointment against the posts of Accounts Assistants vide their No. referred to above, were deputed for undergoing one year's ACC training vide Order No. 198-Acctts of 2016 dated 06.09.2016, 210-Acctts of 2016 dated 04.10.2016 and 231-Acctts of 2016, dated 20.10.2016;

Whereas, they were supposed to join in Northern Zonal Accountancy Training, Institute, Jammu/Accountancy Training Institute, Srinagar within a period of 21 days from the date of issue of the Order;

Whereas, as intimated by the Principal, Northern Zonal Accountancy Training, Institute, Jammu/Accountancy Training Institute, Srinagar vide their Nos. A/Zonal/J/2015/580 dated 30.09.2016 and ATIS/2016/1088 dated 04.10.2016 respectively, these selectees failed to join in the respective training Institutes within the stipulated period of 21 days;

Whereas, a notice was issued vide No. DGAT/E-III/G-21/129 dated 24.10.2016 through print media and official website informing the concerned selectees/absentee that consequent upon their failure to join/report in the concerned training Institutes, their selection shall be cancelled and the Waiting Lists furnished by the Services Selection Board shall be operated against their places. These selectees/absentee were also given a chance to file their objections, if any, to this effect within seven days from the date of issuance of the aforementioned notice;

Whereas, no objection has been filed by the concerned absentees/droup-outs in this behalf within the stipulated period which made it clear that they have no objection to the cancellation



of their selection as Accounts Assistants, recommended by the Service Selection Board vide their No. referred to above.

Whereas, among others, the selection of the **08 candidates**, listed in **Annexure-"B"** to this Order, was repeated in more than one District or District as well as State Cadre or vice-versa, indicated against each under relevant column, by the Services Selection Board vide their Nos. referred to above;

Whereas, these candidates were deputed for undergoing one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu/Accountancy Training Institute, Srinagar vide this office Order No. 198-Acctts of 2016 dated 06.09.2016 and were asked to exercise their option in the form of an Affidavit, duly authenticated by Judicial Magistrate 1st Class, for selection against one of the posts against which their selection was recommended/repeated in a particular District/State Cadre;

Whereas, on exercise of their option, their selection has been considered according to their option and against the posts which they opted for and in the relevant column in **Annexure-"B"** to this Order; and

Whereas, consequent upon exercise of their options, the posts which they opted out under different categories in different Districts/State Cadre are shown in concerned Districts/State Cadre under relevant categories against each in **Annexure-"B"** to this Order for operation of Waiting Lists wherever available.

In view of above, sanction is hereby accorded to the:-

- i. cancellation of selection/deputation for one year's ACC training in respect of 08 candidates, listed in Annexure-'A' who failed to join in the training Institues within the stipulated period and cancellation of selection of 08 candiates against the posts which they have opted out, listed in Annexure-'B' to this order, who were selected by the Service Selection Board as Accounts Assistants in Finance Department in the Main Selection Lists under different Categories in different Districts/State Cadre vide its No. referred to above; and
- ii. deputation of 12 candidates, listed in Annexure-'C' to this order, selected by the Service Selection Board as Accounts Assistants in Finance Department in Waiting Lists under relevant Categories in concerned Districts/State Cadre vide its No. referred to above, for one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu/Accountancy Training Institute, Srinagar, shown against each, which shall commence w.e.f. 26th of December, 2016.



During one year's ACC training these candidates/selectees shall be entitled to stipend as admissible under rules.

The selectees shall report to the Principal, Northern Zonal Accountancy Training, Institute, Jammu/Accountancy Training Institute, Srinagar, as indicted against each in Annexure-C to this Order, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.


In case any selectee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu/Accountancy Training Institute, Srinagar, they shall be formally



placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
