Consequent upon selection of **Mr. Mukhtar Ahmed Bhat S/o Late Abdul Kareem Bhat R/o Abi Karpura, Nehru Park (Dal Lake), Srinagar and Mr. Karanvir Dutta, S/o Mr. Vimal Kumar Dutta, R/o H.No. 400/344 Lane No. 17, Raipura Mangotrian, Shakti Nagar, Jammu** as Accounts Assistants (Apprentices) in Finance Department vide Government Order No. and date referred to above, sanction is hereby accorded to their deputation for undergoing one year's ACC training (six month's theoretical and six month's practical) in Accountancy Training Institute, Srinagar/Northern Zonal Accountancy Training Institute, Jammu.

During one year's ACC training period the candidates shall be entitled to stipend as admissible under rules.

The selectees shall report in the training Institutes within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Sports Category Certificate.
7. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the appointees fail to join within the stipulated period of 21 days, their appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Sports Category Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointees from the concerned Issuing Authority to be got done by the Principal of the training Institutes.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's training at Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar they shall be formally placed as Accounts Assistants in the PB-1, ₹5200-20200 + Grade Pay ₹2800 as admissible under standing rules.


