In case the selectee fails to join within the stipulated period of 21 days, his selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
